IN 2011, LUCKY DOG SAVED 1,333 ANIMALS FROM CERTAIN EUTHANASIA IN HIGH-KILL SHELTERS THROUGHOUT SOUTH CAROLINA, NORTH CAROLINA, VIRGINIA, WEST VIRGINIA, AND MARYLAND. THE VAST MAJORITY OF THESE DOGS WERE PLACED IN CAREFULLY SCREENED, LOVING ADOPTIVE HOMES. THOSE THAT WERE NOT ADOPTED IN 2011 REMAINED IN FOSTER CARE INTO 2012 WHERE THEY STAYED UNTIL THEY FOUND THEIR OWN ADOPTIVE HOMES. IN 2011, LUCKY DOG HAD A 100% SUCCESS RATE, MEANING THAT EVERY DOG RESCUED WAS SUCCESSFULLY ADOPTED OR PLACED IN A LONG-TERM FOSTER SITUATION.
